RiskTalk is an app which guides workers through risk assessments, safety observations and reporting incidents and hazards by speaking directly into their phone or tablet. This allows for quick and easy reporting of incidents and hazards, enabling real-time reporting and data collection. The app meets legislative requirements, ISO 45001 and assists with e-auditing.

Who should use RiskTalk?

RiskTalk is ideal for anyone in environments where there are risk management conversations occurring.

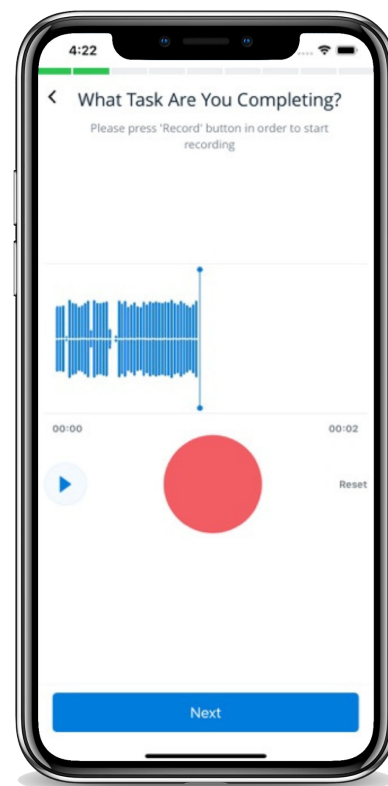

How does it work?

The app guides workers through pre-formulated questions, customised by managers, which are answered by speaking directly into the device and uploading photographs. This removes barriers to safe work and dissolves the need for handwriting.

The platform can be operated offline to enable reporting, even in environments that are continually changing or without reliable access to network coverage. With remote access, managers can listen to live activities and provide immediate sign offs with ease.



The data:

Access all your safety data including real-time lead indicators, automated risk registers, critical risk exposure, amendment rate, key phrase analysis, photo capture and time geo stamped activities.

All assessments can be converted into a report in PDF format through in-built, voice-to-text technology which transcribes the speech. The speech can also be translated into over 200 languages.
